Unapproved St. John Lutheran Church Council Minutes December 9th, 2024

President Albert Koepp called the meeting to order at 6:34 p.m. Present:

Opening Devotions:

Pastor Ted opened the meeting with scripture verses read this time of year and a prayer.

Approval of Minutes:

Members of Council reviewed the minutes from November 11th, 2024. Council Meeting. Motion was made, seconded and carried to approve the meeting minutes from November. A motion was made, seconded and carried to approve the agenda for December 9th, 2024 with a change of order to allow the Property Manager to address the Council first and to add items D. Website Proposal, E. Building and Ground, F. Jan 8th, G. Synod - MSP Document under new business.

Pastor Ted Report:

Things to Consider in the Upcoming Months Christmas Worship The worship schedule will be the same as previous years, (Christmas Eve - 3,5,7 & Christmas Day – 9).

Be Aware About My Ending – the timing of a new pastor arriving is in the range of 5 or 6 months, at the earliest, after the Call Committee begins. If we launch the Call Committee in January, we are looking at May or June at the earliest. Of course, it could happen sooner than that or slower, but we should begin thinking about it. The Interim Contract obligates the congregation to compensate me for one month after I complete my work. It would be best if I am finished at least one month ahead of the new pastor arriving so that the congregation is not paying two pastors at the same time. This of course could have implications for the 2025 budget, and I expect the congregation will begin asking about this.

Promoting Newly Identified Priorities and Characteristics

I think it would be good to start publishing, promoting and in general talking about the priorities identified through the work of the Transition Team, as well as the characteristics of a new pastor that were identified. As the CC launches and begins looking for a pastor, it would be valuable to be reminding the congregation of what we have identified to focus everyone's attention.

Synod Document

I received a document from the Synod with some things they would like us to do to prepare for the Bishop's visit at the Annual Meeting. We will need someone to oversee carrying out the actions they have requested. Who will that be?

New Members I intend to conduct a New Members Class in January.

Staff Reports:

The custodian, Sarah Padgett, is no longer employed. Currently looking to fill the custodian position. No Transfers in or out this month.

Treasurer's Reports:

Jerold presented the November financial report. The General Fund, Building fund and General operating fund were reviewed with the council members.

Transfers:

No Transfers in or out this month.

Ongoing Business:

A. First Call Committee

a. Dave reported that a meeting will be held to discuss the information needed to start the recruiting process for the Call Committee. The First Call Committee meeting is scheduled for January, 21st, 2025.

B. Transition team monthly update - a discussion was had on the impact of the Ministry Site Plan (MSP) on the 2025 budget. A motion was made, seconded, and accepted to adopt the MSP.

C. Property task force provided an update that the city likes the new plan and they feel it's ready to be reviewed with a professional design and plating firm. Next step is to review with the plan with building and grounds.

D. Sheila Schmidt replacement - Pastor Ted gave an update that Eileen Hanson has agreed to play on Wednesdays for worship and potentially for the choir. This is temporary at least through the school year. Rachel Kelm, Tracy Scheer, and Stephanie Paulson have volunteered to lead singing during Wednesday night worship.

New Business:.

A. 2025 budget - a discussion was had on the 2025 budget. A motion was made, seconded, and accepted to approve the 2025 budget.

B. Annual meeting date January 26 - A discussion was held regarding the agenda for the annual meeting. The bishop will be attending and will need an hour to review the Ministry Site Profile (MSP).

C. Property Manager, Kim Meierbachtol addressed that the Rental leases are up in April 2025 and a discussion was had on increasing the rental amount to cover the property taxes. A motion was made, seconded and carried to approve the new lease for April 1, 2025 to raise the rent on each property \$100.00 per month and do a month to month lease on the parsonage house and a year lease on the Hayden house

D. Website proposal - Amanda would like to redo the website with the goals of updating to a new modern layout and allowing it to be easily edited in years ahead without the need of future technical assistance. Chris will look at recruiting interested parties to assist in the redesign. It's estimated to cost \$1500 that will come out of the technology budget.

E. Building and grounds update - Building and grounds committee provided an update regarding the audio visual enhancements. A discussion was had regarding combining the technology committee with the building and grounds committee. A motion was made, seconded, and approved to combine the committees.

F. Jan 8 - A brainstorming session will be held on January 8th for all council and committee members.

G. Planning MSP - Pastor Ted shared a document "Planning your Congregation's Ministry Site Profile". The transition team will write a summary of the MSP that can be distributed to the members of the congregation. A greeter was assigned to be a host to the bishop.

Ministry Team Updates:

A. The Children's Ministry report was reviewed by the council members who reviewed the quarterly report. They have completed the following accomplishment.

a. Added more members to their team.

b. The Sunday Schoolers are enjoying serving coffee hour.

c. They have planned the Christmas program.

d. Working on cleaning out the Art room.

B. The members of the council reviewed the quarterly report from the Personnel Committee. They have completed the following:

a. Completed reviews for the Treasurer position and Adult Worship Choir Director.

b. Eileen Hanlan will fill the Accompanist role for Adult Choir and Wednesday night worship service through December 2024 and possibly longer.

c. Pastor Ted will schedule 1 staff meeting a month with: Church Communications Director and Office Support & Custodian.

d. The Personnel Committee will review the Minneapolis Area Synod - Compensation guidelines to determine Family leave/employee benefits.

Motion was made, seconded, and carried to adjourn the meeting at 9:12 p.m. Meeting was adjourned followed by the Lord's prayer.

From Pastor Ted:

2025 – Let's look back and look ahead.

Last January this article focused on the need to get committees up and running. We identified a year ago some vital things that committees provide for the life of a congregation. **Congratulations!** We have seen all of the following happening, as our committees are functioning nearly 100%.

- Committees get people involved in the actual hands-on work of the congregation. The people involved in the committee are the ones best suited to make decisions because they know what is going on in that area of the church's ministry and they care. When committees are active the best decisions are being made and thus the most effective ministry is taking place, and the work can be very rewarding.
- Committees provide a place for people to put their faith into practice. Sure, there is some planning and decision making involved but then, concrete ways to make a difference emerge as the committee puts its plan into action. People actively involved in committees have a way to be involved in things they are passionate about like children and youth ministry, worship life, the larger community or Bible study or small groups or providing social connections, building community, the list goes on and on.
- Committees have a big impact on the direction of the congregation's ministry efforts. Church Councils work best when they empower committees to make decisions and do the work of the church. Pushing as much decision making as possible down to the people who are the hands-on planners and workers avoids the bottleneck some Councils can become. When committees have permission to go do the work of the church within broad boundaries, they can create new ministries for unmet needs, do old things in new ways that bring a freshness to church life, and they have a giant impact on what gets done in the church.
- Finally, committees provide social connections for the people involved. Friendships are created when you work with someone on important matters or matters that are important to you. Generating ideas, the give and take of decision making and putting a plan into action create positive bonds as the goal is accomplished.

And this NEW YEAR we have more great news.

On January 13, the Church Council is set to "appoint" the Call Committee.

- On January 21, a Minneapolis Area Synod representative will be here to help the Call Committee get organized and launched.
- On January 26th, Bishop Jenn Nagel will join us at our Annual Congregational Meeting to go over our Ministry Site Profile (MSP).
- In February, the Call Committee will be up and running and will begin their search.

You may or may not know!


